TERMS

Buyer agrees to pay the purchase price for all products/services ordered by itself or its agents that are provided pursuant to this agreement in accordance with the credit terms as specified. Quality Aire may change the payment terms from time to time and withdraw credit privileges without notice to the Buyer.

Sums due Quality Aire hereunder are payable at Quality Aire offices in Franklin, VA. If invoices are not paid according to terms of sale, then the account will be considered past due. If Buyer's account becomes more than thirty (30) days past due, Buyer agrees to pay a FINANCE CHARGE of one and one-half percent (1.5%) per month, eighteen percent (18%) per annum.

It is further understood and agreed that if this contract or any debt owed to Quality Aire is referred to a collection agency or attorney, Buyer agrees to pay, in addition to the balance of the account (which includes, but is not limited to, principal, accrued interest, and late charges), all collection fees in the amount of thirty-three and one-third percent (33-1/3%) of the total unpaid balance due, plus court costs and filing fees incurred by Quality Aire. Buyer agrees to pay the aforesaid attorney's fees and costs of collection whether or not suit is filed. Buyer also hereby waives their homestead and all other exemptions to this debt. Buyer further understands and agrees that should Quality Aire be awarded judgment relating to this contract or any debt incurred thereof, Buyer will pay judgment interest of one and one-half percent (1-1/2%) per month, eighteen percent (18%) per annum, beginning on the date of the judgment.

Buyer agrees that the City of Franklin, Virginia shall be the proper venue for any action brought pursuant to this agreement. A photocopy of this contract shall be considered as valid as the original.

All information stated in this application is correct to the best of Buyer's knowledge. Buyer understands that Quality Aire will retain this application whether or not it is approved. Buyer hereby authorizes Quality Aire and its agents to check Buyer's credit, references herein listed, or any other information stated herein to make its credit determinaton.
